**Sub : Statements given by Honorable Member of Parliament namely Shri. Doddalahalli Kempegowda Suresh (D K Suresh), Member of Parliament from Bangalore Rural constituency, Karnataka on 01.02.2024 endangering the Sovereignty, Unity, and Integrity of Republic of India; Seeking for disqualification of D K Suresh from LOK Sabha.**

1. I wish to bring to your kind notice that on 01.02.2024, Honorable Finance Minister, Government of India, Smt. Nirmala Sitaraman Ji has presented the Interim Budget for the year 2024 in Parliament of India, the Temple of Democracy. Once the Budget speech had concluded in the Parliament, Honorable Member of Parliament from Bangalore Rural constituency, Karnataka namely Shri. Doddalahalli Kempegowda Suresh (D.K. Suresh) has given statements to the Media in New Delhi, endangering the sovereignty, unity, and integrity of India. The utterances made by Shri. duty of every citizen of India to show allegiance to the Constitution of India. However, Sri. D K Suresh has violated this very fundamental duty.

3. I as a member of Legislative Council of State of Karnataka, and as a citizen of this great Nation, I am appalled by the irresponsible and anti India statements made by Honorable Member of Parliament Sri. D.K. Suresh. Sri. D K Suresh has violated and breached the oath of office which was administered by your august office. Honorable Member of Parliament Sri. D K Suresh has violated Constitutional norms and Constitutional proprieties.


4. Apart from making such irresponsible statements, Sri. D K Suresh has gone on to substantiate his stance on demanding a separate Nation in his subsequent interviews to the Media.

5. I hereby bring to your kind notice that in terms of Article 99 of the Constitution of India, very member of either House of Parliament shall, before taking his seat, make and subscribe before the President, or some person appointed in that behalf by him, an oath or affirmation according to the form set out for the purpose in the Third Schedule. In terms of the Third Schedule to the Constitution of India, Sri. D K Suresh was administered oath in the Parliament that he would bear true faith and allegiance to the Constitution of India as by law established, that he will uphold the sovereignty and integrity of India and that he will faithfully discharge the duty. However, the statements made by Sri. D K Suresh on 01.02.2024 has a separatist mindset and is igniting passions by which he is has violated all forms of Constitutional propriety.

6. In view of the anti India statements made by Sri. D K Suresh endangering the very sovereignty, unity, and integrity of India, I hereby urge and pray before your august office to disqualify the Honorable Member of Parliament, Sr. D K Suresh, from Lok Sabha, since he has breached the oath of office and hence he has no right to continue his office as a Member of Parliament.
