On 14/05/2025 complainant Sri Suhas have given a complaint fact which state that during 3rd December 2021, Mr. Niranjan S Mayur and Mr. Madhusudhan Binani approached me to start a company in the business of cutting tools. Accordingly, Waffe Engineering Private Ltd., CIN: U29269KA2021PTC155192, which was incorporated on 3/12/2021 being situated at Site No.3, Kebbehalla, Rajiv Gandhi Nagar, Srigandadakaval, Sunkadakatte, Bengaluru – 560091. Somashekar, father of Niranjan is the Ex-Assistant, Director in Enforcement Directorate, Government of India and since he could not manage the company personally, made his son the Director of Waffe Engineering Private Ltd As per the discussion, I was handed over the responsibility of Marketing.

That further, I was also made director of the company and I held 3,334 shares along with Niranjan and Madhusudhan.

Since I was in-charge of marketing, I was made an authorized signatory on the instructions of Niranjan but Niranjan and Somashekar had been controlling Waffe Engineering Private Ltd., and were responsible for the decisions of the company. I was just asked to sign and give cheques as instructed by Somashekar and till today I have been doing the same.

Further in the month of February 2022, Niranjan decided to enter the market of Manufacturing of aerospace components and he started meeting several people and he was introduced to Mr. M. V. Ashoka, Director of SLN CNCTECH PRIVATE LIMITED by Mr. Madhusudan Binani. The said Binani was also a director of the said Waffe company. One Mr. Ashoka portrayed that SLN CNCTECH PRIVATE LIMITED was in the business of aerospace components, that he had expertise in manufacturing and he was getting orders and that he was ready for sale of his company. As he could put more effective output through this method of sales and manufacturing.

Ashoka explained to Niranjan about his immediate need of Rs.25 lakhs and asked him for a total investment of Rs.5 crores. Niranjan, Somashekar and Ashoka have conspired and Niranjan agreed to invest the initial Rs.25 lakhs and upon the instructions of Niranjan, Rs.25 Lakhs was transferred to the company of Ashoka. An amount of Rs. 25,00,000 was transferred on 25/03/2022 to SLN CNCTECH. The conspiracy to knock away the business, equipment's and other necessary financial aspects.

Further, Ashoka stated that SLN CNCTECH had received a notice of Rs.2 Crores from Janata Seva Bank and approached Niranjan to help his company and Niranjan again asked me to transfer Rs. 1.9 Crores to the account of SLN CNCTECH at Janatha Seva Bank. The money sought to be transferred from the account of the waffe company, though the company had no such huge resources to give. It was only the son of Somashekar and his wife Rathna gave the money to the company, the same inturn was deposited into the Waffe account and later shifted to the SLN account initially though could not be suspected now it is clear this is ill-gotten money of Somashekar being converted into accountable money like this mode.

To cover up the transaction, Ashoka sold 8 VMC machines to our Company Waffe Engineering Private Ltd., and assured that we could start manufacturing of aerospace components and all the business of SLN CNCTECH would be handled by our company Waffe Engineering Private Ltd. This was shown on paper, but never came to the premise of waffe company. I was not allowed to open or question any decisions as Somashaker used to threaten or intimidate telling me that he would use his official powers to subdue me.

Fearing for my career I have kept quiet all these days.

Further, during April 2022, Niranjan and Ashoka convinced us to enter into an agreement with the Ashoka for renting a premises at #15-16, 7th Cross, Rajagopal Nagar Main Road, Ganapathi Nagar, Peenya 2nd Stage, Bengaluru – 560058 and the rent was discussed as Rs 12 Lakhs per annum. Wherein the machineries was still with the SLN company, which should have been in the premise of the waffe company.

Due to age-related problems, Madhsudan Binani resigned and left the company. Ashoka and Niranjan have conspired to get M A Karthik i.e., Ashoka's Son to be inducted as a shareholder for the place of Binani. M A Karthik was added as a director with equity holding of 33.33% on 4 Aug 2022. The share transfer agreement was executed between Madhusudhan Binani and M A Karthik dated 11 Aug 2022.

During the entire period, I was in-charge of Marketing and Business Development of Waffe Engineering Private Ltd. Niranjan and Ashoka were responsible for all the financial transactions of Waffe Engineering Private Ltd. Further, Ashoka on behalf of Karthik was handling the operations of the Company.

After, taking over Waffe Engineering Private Ltd., during December, 2022, Ashoka using the name of Waffe Engineering Private Ltd., had taken several loans on pretext of running Waffe Engineering Private Ltd., and several people started visiting the company in search of Ashoka for recovery of the loan. I have informed Niranjan and Somashekar about the situation and he said that he will discuss it in private with Ashoka and Karthik. These loans were never in the knowledge of mine to take any proper action in accordance with law.

It has further come to my knowledge that Niranjan and Karthik along with Ashoka have also started a company parallelly known as Ind Axis Consultancy Services and Mylar Packaging which deals with similar business as Waffe Engineering Private Ltd. Both Niranjan and Karthik have deliberately routed the money earned from Waffe Engineering Private Ltd., through the accounts of Ind Axis Consultancy Services and Mylar Packaging and have caused a wrongful loss to Waffe Engineering Private Ltd., and me.

During October 2023, Niranjan and Karthik sold all the machinery and accessories available in the facility belonging to Waffe Engineering Private Ltd., (No:107 SRS Road Peenya, 6th cross Peenya Industrial Area, Bangalore-5600058) and I was forced to transfer the money to their accounts. Further, Niranjan and Karthik have exited from Waffe Engineering Private Ltd., without my knowledge by taking all the money from Waffe Engineering Private Ltd., leaving behind liabilities of Rs.80 Lakhs on my head.

Niranjan, Somashekar Karthik and Ashoka from the inception have conspired to cheat me and have tactfully opened new companies and have diverted all the funds of Waffe Engineering Private Ltd., to Ind Axis Consultancy Services and Mylar Packaging and have exited Waffe Engineering Private Ltd., without my knowledge and thereby causing wrongful loss to me.

I state that all physical assets have been sold by somashekar and his son for their pecuniary benefits and moreover the cheques have been issued to vendors of the waffe company are still to be paid. Now on account of this malicious move made by the somashekar and his son has made the waffe company financially irrecoverable and vulnerable in the market.

I, therefore request your good selves to register an FIR against Niranjan, Somashekar, Karthik and Ashoka for cheating, committing fraud, criminal breach of trust and take action against them and provide

justice to me.
